## Briefly summarize (2-3) sentences) overall progress and accomplishments applicable to this time period.

We are currently awaiting permitting approval from CDFW for the larger site along Seiad Creek. The other two sites will not require permitting as MKWC has developed plans to complete manual work on the two Off-channel pond sites to increase connectivity quality and duration. We are currently seeking a qualified contractor to complete the mechanical work in the main channel on Seiad Creek which will entail adding three wood structures to increase flow into two side channels that provide increased high quality off-channel habitat, and with increased flow will dramatically improve connectivity to a 6000 square foot constructed off-channel rearing pond. Adding wood structures along with the small amount of excavation will encourage more natural stream processes to improve access to these sites. This work will also entail a small amount of excavation to allow water to spread out along the floodplain and into the above mentioned side channels.

Current updates are that permit applications have been submitted to appropriate agencies and we are currently awaiting a response. MKWC is also seeking a contractor for the planned summer implementation.

Due to the covid-19 pandemic, MKWC's field crews have been temporarily laid off until further notice. MKWC has plans to resume field activities starting in May. This is conditional on our crew members feeling safe and comfortable returning to field work. This also includes any and all contractors involved in projects. MKWC is currently seeking an equipment operator to complete all mechanical work. If cases in Siskiyou County or Humboldt County begin to rise at any point this summer, project



activities might need to be delayed in order to protect the safety of our employees and the general public.
